

NOTICE TO BUSINESS PARTNERS ON THE ESTABLISHMENT OF A SHARED SERVICE CENTER

Dear business partners,

we would like to inform you that, effective from 1st of July 2026, begins the operation of a SHARED SERVICE CENTER (hereinafter referred to as "SSC") within the company **MORAVIA STEEL a.s., with registered office Průmyslová 1000, Staré Město, 739 61 Třinec, the Czech Republic, Company ID 634 74 808.**

SSC is a part of the internal structure of MORAVIA STEEL a.s., as a separate specialized department, through which the entire agenda of processing of tax documents (invoices), receivables and payables of individual companies, the specification of which is attached to this notice (hereinafter also referred to as the "**Annex**").

ELECTRONIC INVOICING

- A/ If you are a supplier issuing electronic tax documents to MORAVIA STEEL a.s., as well as individual entities listed in the Annex, the agreements on electronic invoicing have already been concluded, as well as the e-mail addresses designated for sending electronic invoices (see Annex) remain valid.
- B/ If you are a recipient of goods or services supplied by MORAVIA STEEL a.s. or by any of the entities listed in the Annex, the agreements on electronic invoicing remain valid with your consent as the recipient of electronic invoices.

In both of the above mentioned cases ad A/ and ad B/, the only change is that tax documents will be processed and issued (on behalf of the entities listed in the Annex) by MORAVIA STEEL a.s. via SSC (except for entities marked with * in the Annex).

- C/ If you have not yet used the electronic invoicing, we recommend you to consider this form of invoicing in order to simplify future processes. If you are interested, please contact us. We prefer to submit tax documents in electronic form.
